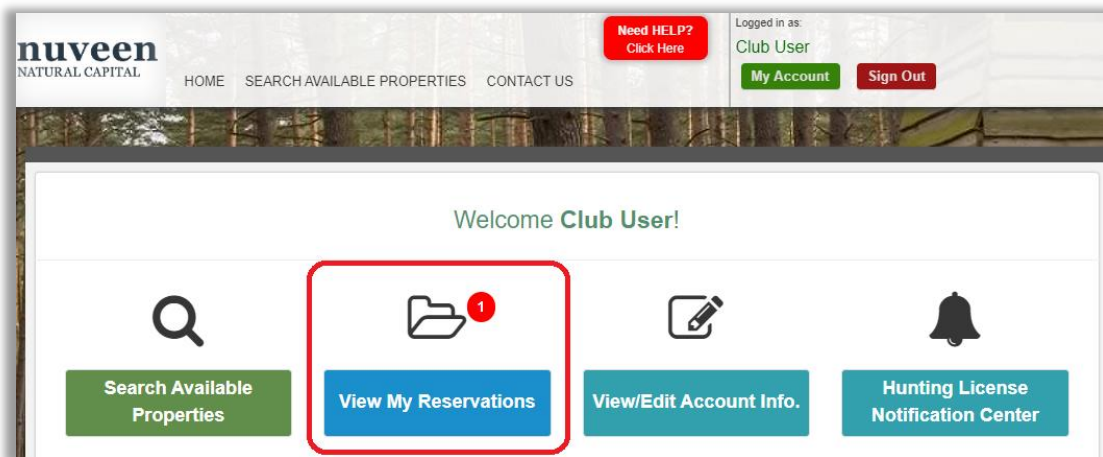
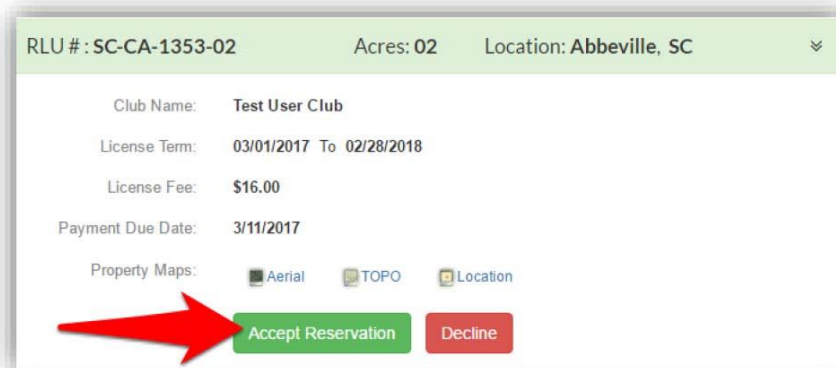


How to Create Your E-License Agreement

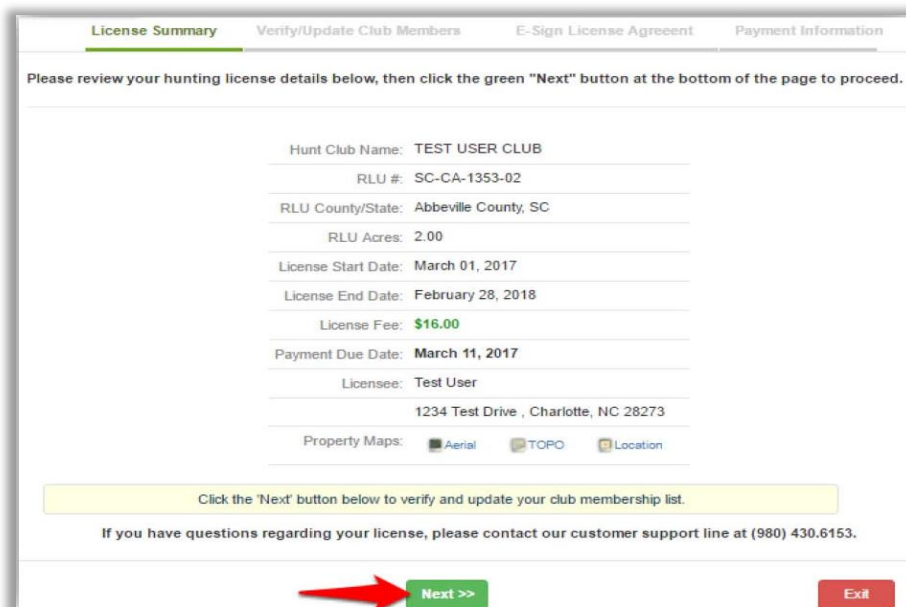
Login to the website, arriving at the “My Account” page. Click on the View Reservations Button



You will be directed to the “Reservations” page where you are given the opportunity to accept your reservation and E-sign your license agreement. To begin, click the “Accept Reservation” button.



License Summary: Displays the reservation information for your club. Verify that the RLU number, price, payment due date, and the License start, and end date are correct and click “Next” to proceed to the next tab.



Verify Club Members: Displays your hunt club's information. It is very important that you make sure this page lists all your club's members with their correct address, phone number, and email address. Click "Next" to proceed to the next tab

2. This License is hereby granted for the sole purpose of non-commercial hunting and fishing for wild game

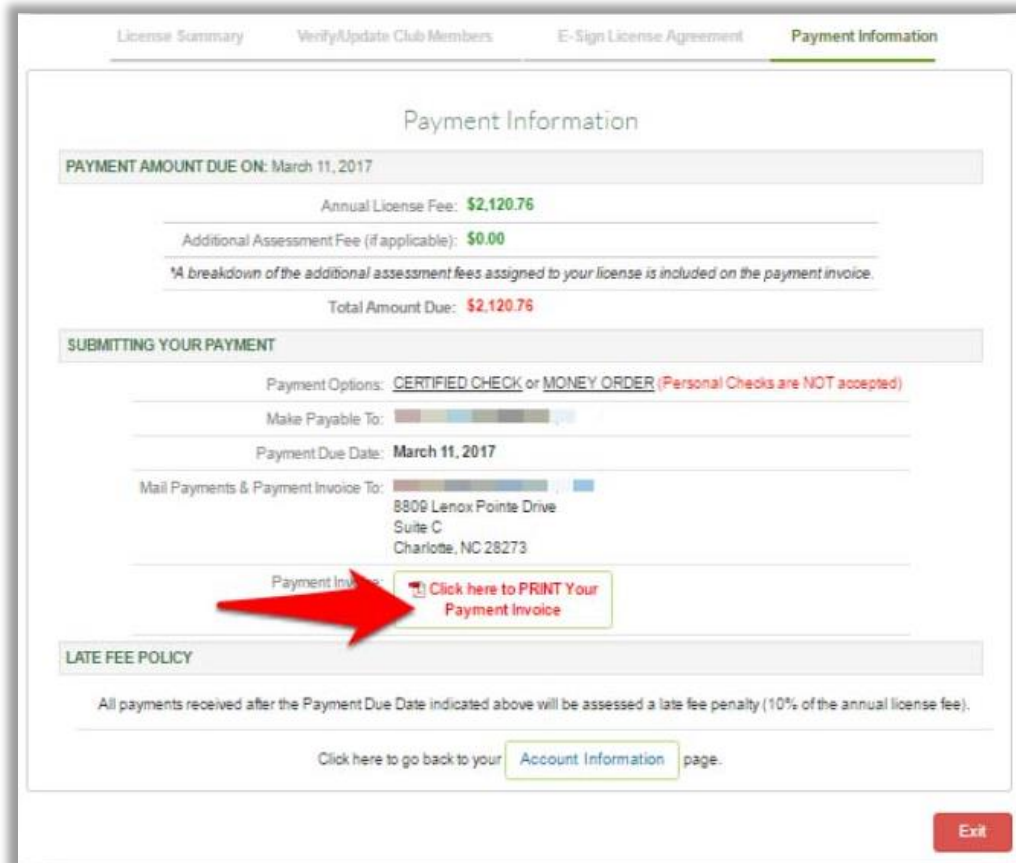
